1. Original **National Identity card** or **valid passport**;
2. Original Academic and Professional Certificates;
3. Any other relevant documents

Successful candidates shall be required to present Clearance Certificates from Higher Education Loans Board (HELB), Ethics & Anti-Corruption Commission (EACC), Directorate of Criminal Investigations (DCI), Kenya Revenue Authority (KRA) and Credit Reference Bureau (CRB); at the time of offer of appointment.

Candidates are advised to report at least **an hour before** the scheduled time.

Interviews will be held at the County Public Service Board Offices located opposite Voi prisons.
